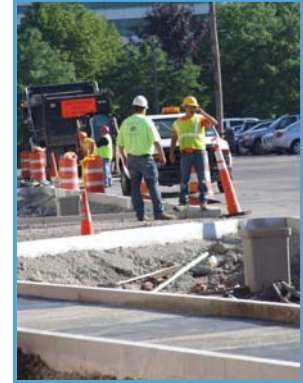

## Highlighted Projects:

### ➤ **Buffalo Niagara Medical Campus Buffalo, New York**

Foit-Albert is managing the rehabilitation of Ellicott Street as the first phase of street improvements throughout the campus. Ellicott Street to be changed to two-way traffic with supporting signage; The road will be milled and overlaid with new curb, sidewalk, landscaping and lighting; Corridor design up to a 25-foot building set-back, with landscape features outside existing City Right-of-Way (ROW) along east side of Ellicott Street; New sidewalks with unique streetscape elements will create a pedestrian-friendly campus setting for the Buffalo Niagara Medical Campus; Building set-backs and open streetscape will provide for an open view shed along Ellicott Street.



### ➤ **CR23 Bridge Replacement over the West and Cobleskill Creeks Richmondville, New York**

Foit-Albert Associates has provided construction inspection services for this locally administered federal funded (LDSA) project for the replacement of 2 bridge structures along CR23A in the Town of Richmondville over the West Creek and the Cobleskill Creek.

Scope included monitoring daily construction activities of the contractor for conformance with the contract plans and specifications; taking measurements of all unit price items and compute areas and volumes of completed work; and monitoring the execution of the project's maintenance and protection of traffic plan to assure the contractor adheres to the contract requirements. In addition, the engineer in charge ensured compliance in regard to permitting, keeping the public informed, and coordinating with affected utility companies.
